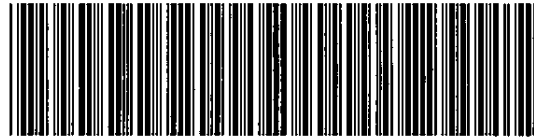

ARTICLE I -Name

The name of this corporation is Mike's Git-R-Done Tool Repair, Inc.

Article II - Duration

This corporation shall have perpetual duration commencing on the date of execution and acknowledgment of these Articles.


