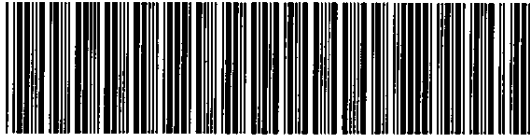



ARTICLE I. NAME




