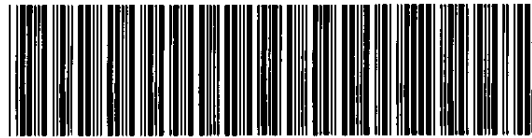


1. The name of the Corporation is DIVISION TEN SPECIALTIES, INC.
