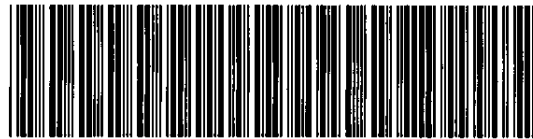

**ARTICLE I  
NAME**

The name of this corporation is ARCE & BARRIOS SERVICES, INC.

ARTICLE XI

If they cannot appoint one within one week of the request the arbitrator will be the Corporation's Legal Counselor. The decision of the arbitrator will be final.
