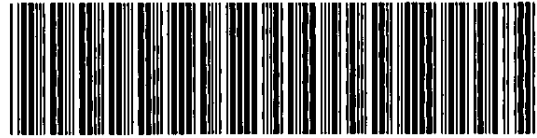

**ARTICLES OF INCORPORATION  
OF  
TROPICAL PAINTING & INTERIOR DESIGN, INC.**

Article I

Name. The name of this Corporation is **TROPICAL PAINTING & INTERIOR DESIGN, INC.**

Article II

Principal Office. The principal place of business and mailing address of this Corporation shall be: 7115 LAUDER PLACE, Tampa, Florida 33617.

Article III

Duration. The period of duration of the Corporation shall be perpetual.

Article IV

Purpose. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States and under the Florida General Corporation Act including the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages, properties, notes, mutual funds, investment trust, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

Article V

Capital Stock. This Corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the Corporation.
