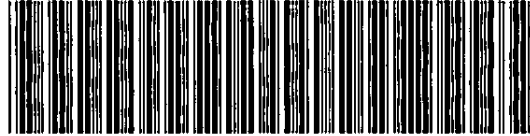

1. Name and Principal Office

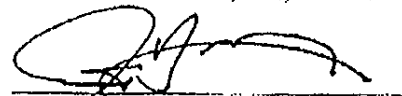
