The undersigned hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be:

RAW AND UNCUT ENTERTAINMENT, CORP.

ARTICLE II

The specific and primary purpose for which this corporation is formed is to engage in the business of the music industry (From songwriting and recording, to distribution and selling) and any other activity or business lawfully permitted under the law of the United States, The State of Florida, and any Country, Territory or Nation.

ARTICLE III

The address of the principal office of this corporation shall be: 730 Nw 75st Miami, Fl 33150.

ARTICLE IV

The Corporation shall never have less than one Director no more than fifteen directors. The directors are elected at the annual meetings.

ARTICLE V

BOARD OF DIRECTORS: the powers of this corporation shall be exercised; its properties controlled and its affairs conducted by a board of directors. The initial number of directors of the corporation shall be four, provided, however, that such number may be changed by a bylaws duly adopted by the corporation.
