ARTICLE I. CORPORATE NAME.

The name of this corporation is LACHLAN, INC.

ARTICLE II. ADDRESS OF PRINCIPAL OFFICE.

One Thousand (1,000) SHARES - Doyle Curtis James, Jr. and Leahna Anne James, as joint tenants with right of survivorship.


