**ARTICLES OF AMENDMENT
of
FIRST COAST OCCUPATIONAL MEDICINE, INC.**

Pursuant to the provisions of Section 607.1005 of the Florida Business Corporation Act (the "Act"), the undersigned incorporator ("Incorporator") of FIRST COAST OCCUPATIONAL MEDICINE, INC., a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Florida Department of State these Articles of Amendment to its Articles of Incorporation as follows:

1. The name of the Corporation is FIRST COAST OCCUPATIONAL MEDICINE, INC. The Articles of Incorporation of First Coast Occupational Medicine, Inc. were filed with the Florida Department of State on June 8, 2006, and was assigned document number P06000079353.

2. The Corporation has not yet issued shares.

3. The Articles of Incorporation of FIRST COAST OCCUPATIONAL MEDICINE, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

ARTICLE I

Name

The name of the Corporation is: **JACKSONVILLE OCCUPATIONAL MEDICINE, INC.**

4. Upon the filing of these Articles of Amendment by the Florida Department of State, the above referred to amendment shall become effective, and the Articles of Incorporation of FIRST COAST OCCUPATIONAL MEDICINE, INC. shall be deemed to be amended accordingly.

IN WITNESS WHEREOF, the undersigned, as the incorporator of FIRST COAST OCCUPATIONAL MEDICINE, INC., hereinafter to be known as "Jacksonville Occupational Medicine, Inc.", has executed these Articles of Amendment on the 4th day of April, 2007.
