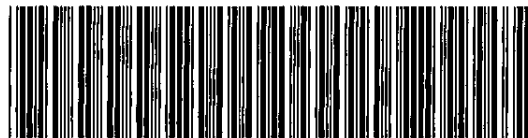

**ARTICLES OF INCORPORATION
of MARC'S AUTO CREATIONS, INC.**

ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

The name of this corporation is: MARC'S AUTO CREATIONS, INC., with initial principal offices located at 8967-1 Phillips Highway, Jacksonville, FL 32256.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of operating a day spa or of engaging in any other activity or business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One hundred (100) shares of stock with the par value of One and no one-hundredths dollars (\$1.00) per share, which shall be designated as "Common Shares".




