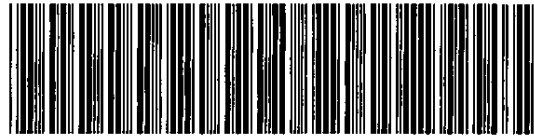



ARTICLES OF INCORPORATION

OF

AMERICAN WOMEN'S CONSULTATION SERVICES, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I

The name of the corporation shall be *AMERICAN WOMEN'S CONSULTATION SERVICES, INC.*.

The principal place of business shall be 15910 U.S. Highway 19, Hudson, Florida 34667.

II

The duration of this corporation is perpetual unless dissolved according to law.

III

The purposes for which this corporation is organized are:

1. To provide consulting services to the general public on general matters.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

IV

The aggregate number of shares which the corporation is authorized to issue is five hundred (500). Such shares shall be of a single class, and shall have a par value of ten dollars (\$10.00) per share.


