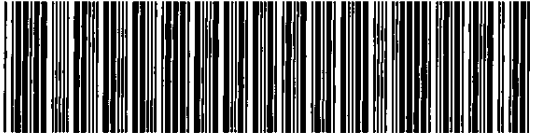

## ARTICLES OF INCORPORATION

---

### ARTICLE I

The name of the corporation shall be SIRI INDUSTRIES CORPORATION.

### ARTICLE II

The copy of the Certificate of Incorporation which was duly filed on with the Secretary of State of Florida on June 15, 2006 will be annexed hereto.

### ARTICLE III

The principal place of business is 11275 Furley Avenue, County of Hernando Brooksville, Florida 34613.

### ARTICLE IV

The purposes for which the corporation is organized are:

To engage in any lawful act or activity for which corporations may be organized under the business corporation law, provided that the corporation is not formed to engage in any act or activity which requires the act or approval of any state official, department, board, agency or other body without such approval or consent first being obtained.

To import, export, sell, lease, market, distribute, transport or otherwise dispose of and generally to deal in and with, as contractor, subcontractor, principal, agent, commission merchant, broker, factor or any combination of the foregoing and at wholesale or retail or both manufactured articles and products, raw materials, natural products and goods, wares, merchandise and tangible property of every kind, used for any purpose whatever.

To develop, experiment with, conduct research on, manufacture, produce, assemble buy, sell, distribute, lease or otherwise acquire, to be a franchise dealer, licensee, hold, own, operate, use, install, equip, replace, repair, maintain, service, process and reprocess, remodel, recondition any and all kinds of communication and video equipment, systems and accessories and all allied apparatus, systems, parts, supplies, tools, and implements, import, export and otherwise deal in communication and video equipment, systems and devices of every kind and description, and other related products at wholesale and at retail and as principal and agent.

The powers, rights and privileges provided in this certificate are not to be deemed to be in limitation of similar, other or additional powers, rights and privileges granted or permitted to a corporation by the Business Corporation Law, it being intended that this corporation shall have all the rights, powers and privileges granted or permitted to a corporation by such statute.

**ARTICLE IV**

The number of shares of stock which the corporation shall have the authority to issue is Two Hundred (200), all of which shall be without par value.
