AMENDMENT TO
ARTICLES OF INCORPORATION OF
CLASCO, INC.

The undersigned, being the President and Secretary of CLASCO, Inc., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The present name of the Corporation is CLASCO, Inc.
2. By written action of the directors and stockholders dated September 21, 2006, the following resolutions changing the name of the Corporation to Protective Industrial Coatings, Inc., and the address of the Corporation to 4749 Distribution Drive, Tampa, Florida 33605 were unanimously adopted in accordance with Sections 607.1003, 607.0704 and 607.0821, Florida Statutes:

RESOLVED that the name of the Corporation shall be changed from CLASCO, Inc., to Protective Industrial Coatings, Inc., and its address shall be changed to 4749 Distribution Drive, Tampa, Florida 33605 effective September 21, 2006.

RESOLVED that, effective September 21, 2006, Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and a new Article I is substituted in its place, which shall read as follows:

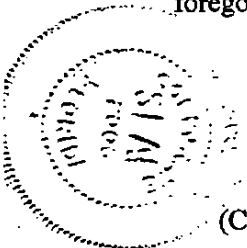
ARTICLE I

Name and Principal Office
