**ARTICLES OF INCORPORATION  
OF**

**ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **IMPLIC'T ENTERPRISES, INC.** and its principal place of business shall be located at **2005 US Hwy 92 E., Lakeland, FL 33801.**

**ARTICLE II- DURATION**
