The undersigned subscriber to these Articles of Incorporation is <u>a Natural Person competent to contract and hereby form a</u> Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, Proposed by them to the stockholders and approved at a stockholders meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.
