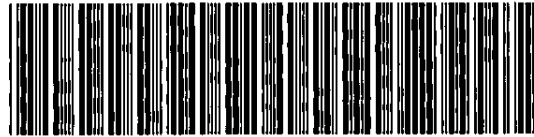

## XIII




