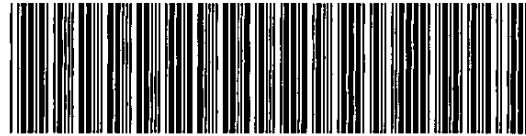



**ARTICLE I**

**NAME**

The name of this corporation is BMS PICTURE SEVEN, INC.

**ARTICLE II**
