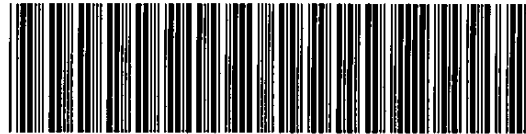

ARTICLE IX

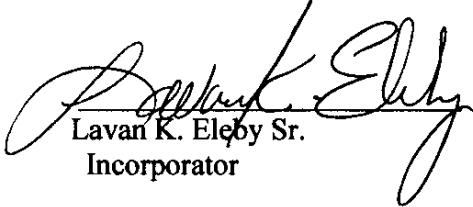
INDEMNIFICATION

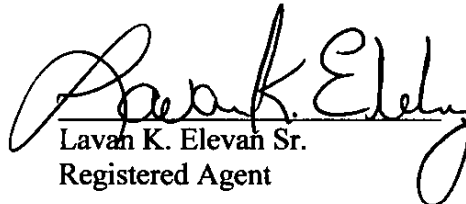
