ARTICLES OF INCORPORATION OF NATALIA FERRER-LEON, D.M.D., P.A.

The undersigned, acting as incorporator of Natalia Ferrer-Leon, D.M.D., P.A. (hereinafter "Corporation") pursuant to Chapter 621, Florida Statutes, desiring to form a Professional Service Corporation for the purposes set forth herein and in conformance with the Professional Service Corporation and Limited Liability Company Act, does hereby establish the following:

**ARTICLE I
NAME OF CORPORATION**

**ARTICLE II

**ARTICLE III
PURPOSE**

This Corporation is organized for the purpose of engaging in any lawful business in which a Professional Service Corporation may engage under Florida law, including but not limited to, the business of providing dental services to the public for profit.

To the extent permitted by law, the Corporation shall indemnify any person who was or is a party to any proceeding by reason of the fact that he or she is or was a director, officer, employee, or agent of the Corporation or is or was serving at the request of the Corporation as director, officer, employee, or agent of another corporation, partnership, joint venture, trust or other enterprise against liability incurred in connection with such proceeding, including appeal thereof, if he or she acted in good faith and in a manner he or she believed to be in, or not opposed to, the best interests of the Corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe his or her conduct was unlawful. The Corporation shall reimburse each person for all costs and expenses, including attorneys' fees, reasonably incurred by him or her in connection with any such liability in the manner provided for by law or in accordance with the Corporation's Bylaws.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he or she may be lawfully entitled, nor shall anything therein contain or restrict the right of the Corporation to indemnify or reimburse such person in any proper case even though not specifically provided herein.

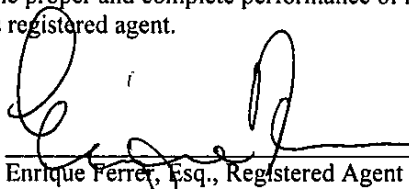
