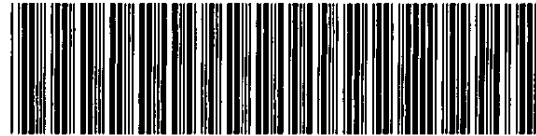

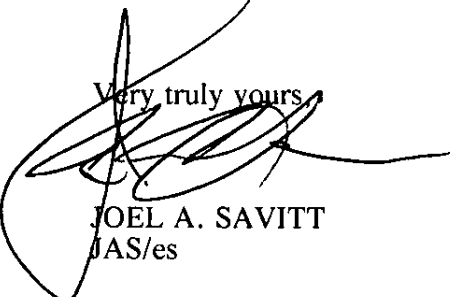

ARTICLES OF INCORPORATION
OF

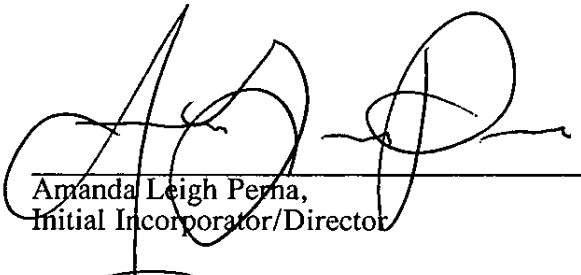

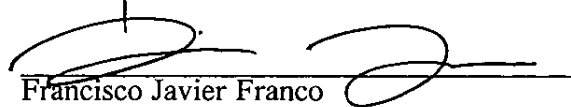
