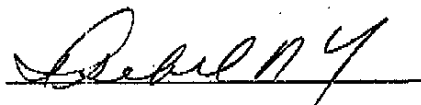

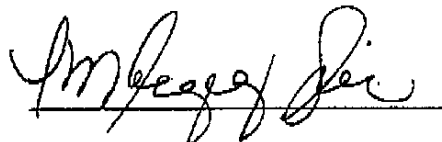
**ARTICLE IX-AMENDMENTS.**
