ARTICLES OF INCORPORATION OF MAKES AND MODELS TALENT, INC.

The undersigned subscriber to these Articles of Incorporation ("Articles"), being a natural person and competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I. - NAME. Makes and Models Talent, Inc. is the name of this Corporation (hereinafter referred to as the "Company").

ARTICLE II. - PRINCIPAL OFFICE. The principal office of the Company is 16102 North Florida Avenue, Lutz, Florida 33549.

ARTICLE III. - DURATION. The Company's existence commenced upon the filing of these Articles with the Florida Department of State, and the Company will exist perpetually, unless terminated in accordance with law.

ARTICLE IV. - PURPOSE. The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
