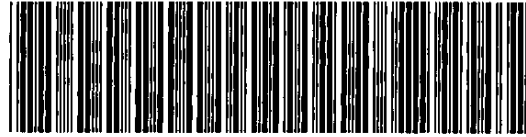

The e-mail came back from you on May 11, 2006 saying the original document was being returned for corrections. (SEE ATTACHMENT)

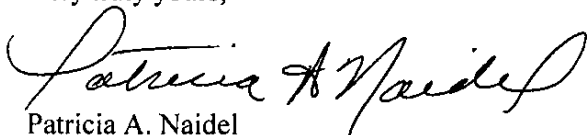
To this date I have never received this notice.

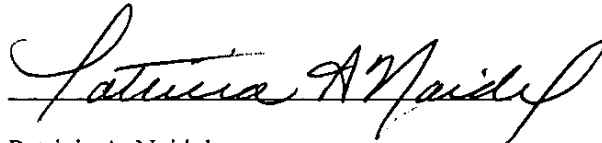
