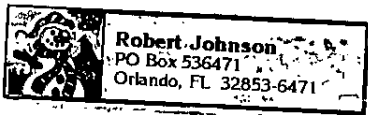

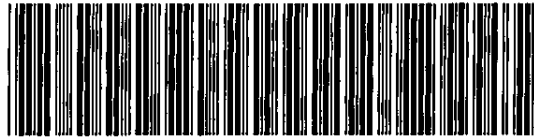

- FIRST: The name of the corporation is RIGHT PLACE, RIGHT TIME, INC.
- SECOND: The period of its duration is Perpetual
- THIRD: The purpose(s) for which the corporation is organized are "To operate an embroidery company and any other lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes."
