THE UNDERSIGNED, subscribed to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE

The name of the corporation shall be:

ARTICLE II

The general purpose of the corporation is to engage in any activities or businesses permitted under the laws of the United States and Florida, including, but not limited to, the ownership and operation of an online auction business.

The term for which this corporation shall exist shall be perpetual and the business of the


