ARTICLES OF INCORPORATION

I, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

Article I

The name of the corporation shall be **HEALTH, ENERGY AND**MEDICINE HOLDING CORPORATION.

Article II

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:
