ARTICLES OF INCORPORATION

The undersigned subscriber to these articles of incorporation, being a duly licensed real estate sales person under the laws of the State of Florida, adopts these articles to form a professional corporation under the Florida Business Corporation Act, the Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional corporation is JEANE B. MYDDELTON, P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal office and mailing address of the professional corporation is 3303 Thomasville Road, Tallahassee, Florida 32308.

ARTICLE III. PURPOSE
