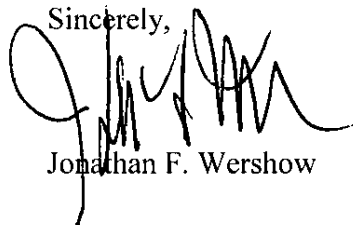

ARTICLES OF INCORPORATION
OF
WILDS DEVELOPMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE I: NAME

The name of this corporation is WILDS DEVELOPMENT, INC.

ARTICLE II: DURATION

The duration of this Corporation is perpetual.

ARTICLE III: NATURE OF BUSINESS

The general purposes for which the corporation is organized are:

1. To engage in the business of operating land development and other related activities.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV: CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue are one thousand (1000) shares. Such shares shall be of a single class, and shall be without par value.

The number of directors constituting the initial board of directors of the corporation are two (2). The names and addresses of the persons who are to serve as members of the initial board of directors are:

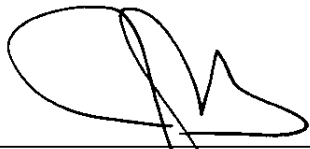
