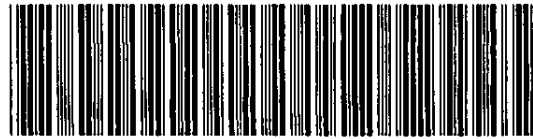

Also, if you could please remove my parents' address that was used without authorization: 4324 Adams St. Hollywood, FL. 33021. My old apartment address: 15360 SW 284<sup>th</sup> St. Apt. 111 Homestead, FL. 33033. Both addresses were used without the permission of property owners by Yevheniy Babenko. At those addresses there wasn't any YB PRODUCTS INC. Yevheniy Babenko who is listed for this "made-up" company used people's information from both addresses that he stole. This person has been committing fraud with many people's stolen identities and is also wanted by the law in Florida for stolen property (Warrant # 10007570CF10A). Please clear my name and my information along with my parents' information (address).
