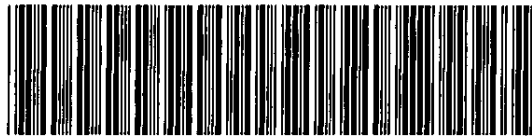

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is SILVA & Partners, Inc. Its principal office address and business mailing address is 20105 N.E. 3rd Ct., Unit # 11, Miami, FL 33179.


