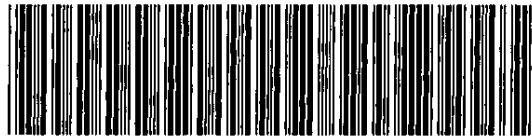

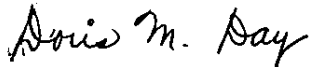

The undersigned, SUBSCRIBER TO THESE articles of Incorporation, natural person over the age of 18 years, competent to contract; to construct manage, operate and maintain computer networking systems in the State of Florida.

ARTICLE ONE
CORPORATE NAME

The name of the corporation is **MANLEY NETWORKING ASSOCIATES, INC.**

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
DEFINITIONS

The purpose for which the corporation is organized is:

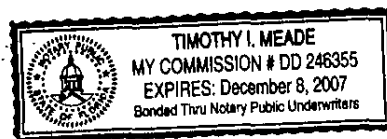

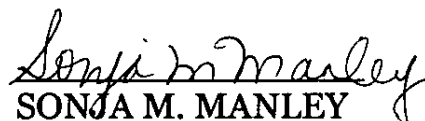

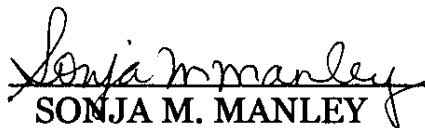
