# ARTICLES OF INCORPORATION

**OF** 

## COLLIER BIZ PAC, INC.

(a corporation not for profit)

OG JUN 21 PM 1: 12

THE UNDERSIGNED, acting as incorporator of a corporation not for profit to be formed under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation:

FIRST:

The name of the corporation (the "Corporation") is:

Collier Biz Pac, Inc.

SECOND:

The initial principal office and mailing address of the Corporation is:

3544 Tortuga Way Naples, Florida 34105

THIRD: The term for which the Corporation is to exist shall be perpetual or until such time as the Corporation shall have been dissolved in accordance with the laws of the State of Florida.

FOURTH: The purpose for which the Corporation is organized is to promote social welfare, and in particular to advance the free enterprise system and to seek out and support ways to advance the quality of life for all residents of Collier County, Florida, and to engage in any lawful act or activity incidental, necessary or desirable in connection therewith for which corporations may be formed and operated under the Florida Not For Profit Corporation Act.

FIFTH: The manner in which the directors or trustees are to be elected or appointed shall be as stated in the bylaws of the Corporation.

SIXTH: The name of the initial registered agent of the Corporation is R & A Agents, Inc. and the street address of the initial registered agent, which shall be the registered office of the Corporation, is c/o Mark J. Price, Esq., 850 Park Shore Drive, Third Floor, Naples, Florida 34103.

SEVENTH: No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. The organization shall not participate in, or intervene in (including the publishing or distribution of statements for) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other purpose not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(4) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

EIGHTH: Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(4) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the

county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
