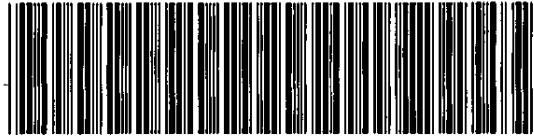

ARTICLE 1. - NAME

The name of the corporation is NE COMBUSTION PRODUCTS, INC.

ARTICLE 2. - PRINCIPAL OFFICE

ARTICLE 3. - MAILING ADDRESS

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

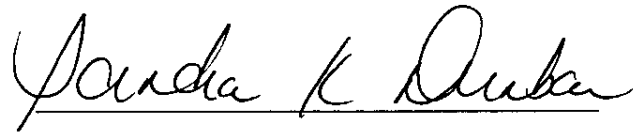

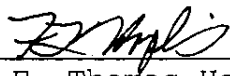
