Dear Sir or Madam:

The corporation "W.D.O & MORE, INC." was newly formed on 6/22/06 and 2007 was the first Annual Report they were required to file. As new owners of a corporation, they were unfamiliar with the requirement of a \$150.00 annual fee and report. They had never received and "ANNUAL REPORT NOTICE" card and did not know what it meant, how to obtain the form that needed to be filed or the threat of dissolution and late fees that might be incurred for failure to respond, nor did they know the importance of obtaining a serious understanding of the card's meaning.

Thus at the time they received the notice card, they did not respond as they did not know the proper response and did not know what was being requested. Because the card does not make clear what an "Annual Report" is or spell out the consequences of failure to respond, we respectfully request that the late payment fee be abated due to the new owners' failure to interpret the notice as a mandatory notice for a response and payment.

Therefore, we respectfully request that you process the regular fee of \$150.00 which is enclosed, along with the 2007 Annual Report for the corporation, and that you preserve the active status of the corporation. Note that we have supplied an FEI # for the corporation. Thank you very much for your consideration.
