The undersigned subscribers to these Articles of Incorporation hereby form a corporation under the Florida Business Corporation Act.

ARTICLE !

The name and address of the corporation is:

VAIPRO EQUIPMENT VALIDATION SERVICES, INC.

ARTICLE II Duration

The duration of the corporation is perpetual.

ARTICLE III General Purpose

The general purposes for which the corporation is organized are:

- 1. To provide validation services.


