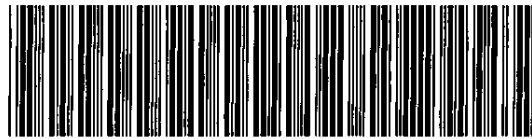

Article I
Identification





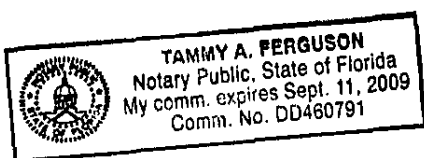
