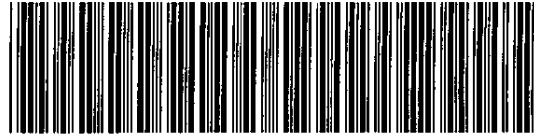

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Quick Response Processing Center, Corp. Its principal office address and business mailing address is 6013 SW 162 Place, Miami, Florida 33193.

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
