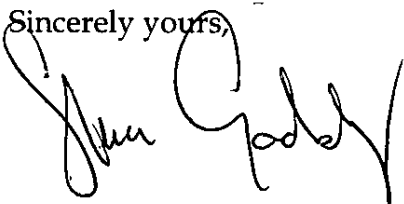

ARTICLE I. CORPORATE NAME.

The name of the corporation is: **S.P.S. Group, Inc.**

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS.

The address of the principal office of the corporation is: 3777 NW 78th Avenue, #11A, Hollywood, Florida 33024.

ARTICLE III. PURPOSE.

The general nature of the business to be transacted by this Corporation is to provide general home repair services.

ARTICLE IV. CAPITAL STOCK.

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock with one dollar (\$1.00) par value.

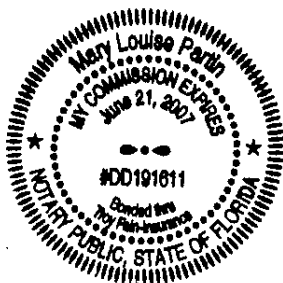

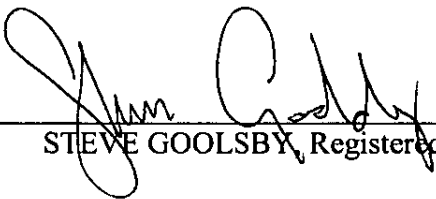
