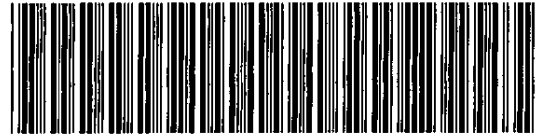


ARTICLE X - AMENDMENT

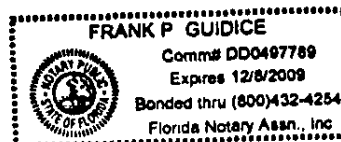
