JUNZE PHY 4: The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida

# <u>ARTICLE I - NAME</u>

The name of this corporation is L & D Creations, Inc.

# ARTICLE II - PURPOSE
