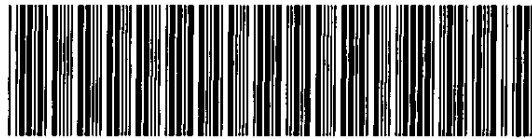



ARTICLE I-NAME

The name of this corporation is COOKSEY HOLDINGS OF INC.

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III- PURPOSE

This corporation is organized for the purpose of purchasing, developing, managing and selling real estate and other property and for transacting any and all lawful business permitted under the laws of Florida.

ARTICLE IV-CAPITAL STOCK




