Article I

Name. The name of this Corporation is Esther Salmi Estate Rock Pit, Inc.

Article II

Principal Office. The address of the principal office of the Corporation is 26317 NW 78th Avenue, High Springs, FL 32643.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose.
