## ARTICLES OF INCORPORATION

of

1800 REID STREET, INC.

The undersigned, pursuant to the Provisions of Section 607.0202 of The Florida Statutes does hereby and herewith file, with the Secretary of State of The State of Florida, these Articles of Incorporation for 1800 REID STREET, INC., a Corporation for Profit organized pursuant to the Laws of The State of Florida.

### ARTICLE I.

The Name of the Corporation is and shall be 1800 REID STREET, INC.

### Article VII.


The Corporation is organized for and is empowered to engage in and conduct any and all businesses, enterprises and activ-

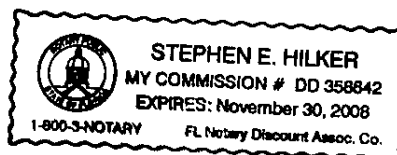


