### ARTICLES OF INCORPORATION

OF

# FUJISAN, INC.

I, the undersigned incorporator(s), hereby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

# ARTICLE I

The name of this corporation shall be FUJISAN, INC..

#### ARTICLE II

The general nature of the business to be transacted by this corporation shall be as follows:
