In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, hereby acts as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is COOLEST DRINK, INC.

ARTICLE II

The existence of the Corporation shall begin on the date of filing of these Articles of Incorporation with the Department of State.

ARTICLE III

The street address of the initial principal office of the Corporation is 1126 NW 2nd Street, Suite C, Gainesville, Florida 32601.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 5000 shares with a par value of \$10.00 per share, all of which shares shall be Common Shares. All Common Shares shall be identical with each other in every

respect and the holders of Common Shares shall be entitled to one vote for each Share on all matters on which shareholders have the right to vote.

ARTICLE V

The street address of the Corporation's initial registered office is 4041 NW 37th Place, Suite B, Gainesville, Florida 32606. The initial registered agent for the Corporation at that address is TERRI HASKINS.

ARTICLE VI
