ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is Randy Michael Collectibles, Inc. and is located at 518 Sawgrass Circle, Melbourne, FL 32940 and mailing address P.O. Box 410099, Melbourne, FL 32941.


