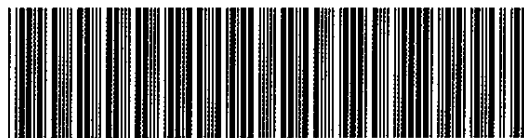

The Corporation may issue 100 (One Hundred) of Voting Common Stock of Par value \$ 5.00--each Share with preemptive Rights preserved


