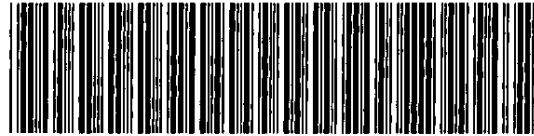



OF

ARTICLE I. NAME

The name of this corporation is
VELA INVESTMENTS CAPITAL, INC.


