Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment Adopted

Amend/Correct ARTICLE IX - MANAGEMENT BY SHAREHOLDERS as follows:


ADD AT THE END OF ARTICLE IX: "The name and street address of the sole surviving shareholder is John W. Carr, 1775 Davis Avenue, Bartow, Florida 33830".
