

THE UNDERSIGNED, being over the age of eighteen years, in order to form a corporation pursuant to the provisions of the Corporate Code, hereby certifies as follows:

Article I  
Identification

The name of the corporation, hereinafter referred to as the "Corporation," is Imperial Water Solutions, Inc.

Article II  
Period of Existence

The period during which the corporation shall continue is perpetual.

Article III


